A. Discuss HB2025 School Visitors Policy Development – From HB2025: 46. DEVELOP AND ADOPT IN A PUBLIC MEETING POLICIES TO ALLOW FOR VISITS, TOURS AND OBSERVATIONS OF ALL CLASSROOMS BY PARENTS OF ENROLLED PUPILS AND PARENTS WHO WISH TO ENROLL THEIR CHILDREN IN THE SCHOOL DISTRICT UNLESS A VISIT, TOUR OR OBSERVATION THREATENS THE HEALTH AND SAFETY OF PUPILS AND STAFF. THESE POLICIES AND PROCEDURES MUST BE EASILY ACCESSIBLE FROM THE HOME PAGE ON EACH SCHOOL'S WEBSITE. Ellen Ryan volunteered to assist Cindy Roe in developing the policy to be presented to the board in November.

Kelly Smith reported requests from faculty:

- i. Limit scheduling to once per month or once per quarter for observations.
- ii. Classrooms can have open doors on observation days for a certain number of visitors; it is best to have 3-5 for grades and only 1-2 for early childhood for silent observation during main lesson times only.
- iii. Parents wishing to observe should already have children enrolled in the school or have submitted paperwork.
- iv. PFS cannot accommodate drop in visitation requests. All visitors for tours or classroom observations must schedule or select already scheduled events.
- v. Parents can request a separate meeting with a faculty member by appointment.
- vi. PFS currently provides tours and can accommodate tours of the campus by request. All visitors wishing a tour of the campus should schedule at least three days prior to arriving.
