- B. Approve FY23 Calendar Cindy Roe presented the calendar and details. Motion to approve the FY23 Calendar by Dave Eckert, 2nd Ellen Ryan. Unanimously approved.
- C. Approve Lifting Mask Resolution Mask optional beginning March 28, 2022. Cindy Roe shared information from CDC and Coconino County for schools. Cases are still high in Coconino County Charter Schools, but are trending downward at PFS. CDC puts Coconino County in the Medium level of risk. Faculty had recommended waiting until one week after Spring Break, but some were ready to lift the mandatory mask wearing. FUSD lifted their mask mandate effective February 28. Communication could go out to families to highly encourage mask wearing to keep classes open and faculty and students in attendance and healthy, patterning the email like the August 2021 communication. PFS will continue protocols set in place by the Pandemic Mitigation Plan. It was suggested that waiting a few days would allow for more clear communication and preparation for families and faculty. 	Meetings – Faculty discussed chapters 4 and 5 in <u>Partnerships of Hope.</u> Dave Eckert recommended that the board read these chapters. Chapter 4 is about group communication, 5 is about the culture of leadership and chapter 6 is about transformation and renewal.

	FTE and enrollment – 180 students are enrolled with 24 of those in Kindergarten. Two new students arrived with one in 6^{th} grade and one in 1^{st} grade. Two students from 3^{rd} and 7^{th} grades moved out of state. Tours continue and open houses are scheduled for April 2 and 14.
	Academic performance – All in-house benchmark assessments have been completed, and adjustments have been made to ensure that students receive the support they need.
	Personnel – Two substitutes were switched to classes needing more assistance. Letters of intention are being submitted for the $22/23$ school year. Kelly Smith is meeting with faculty members.
	School safety – All safety measures continue.

 □ Funding – PFS is funded on 163.5 students. Growing enrollment is necessary. □ Financial report – The corrective action plan was submitted to the ASBCS in early February detailing how measures were mitigated. The board now reviews financial reports, overtime hours have been paid for one employee, and personnel records have been updated.

IX. OLD BUSINESS –

A. Discussion of plan to implement Survey recommendations by Culture Engineered. Dave Eckert presented recommendations from the College of Teachers to address the results of the survey. One was to create a mandate/team to make sure newer employees are included in decisions and changes to create a comfortable and safe atmosphere of collaboration. The use of sharing biographies will be helpful, allowing more familiarity with each other. The second one is to nourish internal relationships to address perceived or real lack of collaboration and teamwork, trust, and transparency. Change is needed for the PFS team to be valued and validated by all. Faculty desired the attendance of administration at all faculty meetings. Faculty wished for a shared commitment to the ideas presented in the book, Partnerships of Hope. The third one is to address pay concerns by educating all employees about the pay scale put in place three years ago, how the budget and state funding work, and how to make pay reflect more about the person. Work will begin with setting the mandate/team and setting all three in motion, but focus will begin on the pay concerns. Dave Eckert and Johanna Payton said that conversations are already occurring, and work will strengthen collaboration and communication.
